# MKYRA Release and Hold Harmless Liability Agreement

IN CONSIDERATION of being allowed to participate in Missouri Kansas Youth Rodeo Association, Inc. sanctioned events and any activity provided by Missouri Kansas Youth Rodeo Association, Inc, the receipt of which is hereby acknowledged, I, \_\_\_\_\_ (the Legal Guardian[if needed]) agree on behalf of \_\_\_\_\_ (the contestant/member/minor or otherwise) with Missouri Kansas Youth Rodeo Association, Inc to the following:

**DETAILS OF ACTIVITY**

- I/We agree and request that the named participant (or minor) be granted permission,
- 1. To enter the restricted area (Restricted defined as, the area from which admission to the general public is restricted, which includes, but is not limited to, the rodeo arena, competition area, chutes, back pens, holding pens, adjacent walkways, concessions, and other appurtenances.
  - 2. To participate as a contestant, or otherwise, in Missouri Kansas Youth Rodeo Association, Inc., Rodeo events,
  - 3. To compete for money, prizes, recognition, or reward,
  - 4. To be covered by participant/contestant’s own hospitalization medical insurance, If applicable.

**CONSIDERATION OF INHERENT RISK**

I/We, on behalf of the minor, ourselves, our personal representatives, heirs, next of kin, spouses, and assigns, do hereby, understand that a minors (or any stated above) entry into the restricted area and/or participation in MKYRA Rodeo events contain Inherent risks and potential dangers of injury or death. I/We understand that conditions of the rodeo arena change rapidly and may become hazardous. I/We recognize and warrant rodeo animals are inherently dangerous and unpredictable and as such, voluntarily assume, and warrant to Release and Hold Harmless Missouri Kansas Youth Rodeo Association, Inc. I/We (the minor) and all named are aware the arena surface, access ways, lighting, and weather conditions change and a pose danger however, I/we voluntarily elect to accept ALL inherent risks connected with entry into the restricted area and/or participation in any MKYRA Rodeo Events including death, personal injury, and/or damage to property.

**CONCURRENT RELEASE**

I/We, on behalf of the ourselves, (the minor), our personal representatives, heirs, next of kin, spouses, and assigns, do hereby, understand and recognize and warrant that this Release and Hold Harmless Agreement, is being voluntarily and intentionally signed and agree to, and that in signing this Release and Hold Harmless Agreement I/we know and understand that this Release and Hold Harmless Agreement may further limit the liability of any Missouri Kansas Youth Rodeo Association professional.

I/We Release, Discharge, Hold Harmless, and Covenant NOT to sue the Rodeo Committee, Stock Contractor, Rodeo Association, Sponsors, Arena Operators, Arena Owners, in addition to, their officers, agents, and employees (all collectively referred to as “Release” ) release any and all claims from liability whatsoever, including but not limited to, any incident caused by or related to Missouri Kansas Youth Rodeo Association negligence, relating to injuries known or unknown, or otherwise not herein disclosed; injuries, death, property damage from: presence in the restricted area, mounting, riding, dismounting, walking, feeding, use of barns, outside of restricted area in any capacity, falling off, failure to understand Missouri Kansas Youth Rodeo Association professional direction, or participation in any sanctioned event.

**FITNESS TO PARTICIPATE**

I/We certify the contestant/participant is in good health and sufficient physical condition to properly participate in Missouri Kansas Youth Rodeo Association, Inc., activities. I/We are knowledgeable about the proper use of any equipment and safety equipment suggested by Missouri Kansas Youth Rodeo Association, Inc., and will operate such equipment in strict accordance with instructions. **FULL AND FINAL SETTLEMENT**
